A Joint Resolution approving permanent rules of the State Board of Licensure for Professional Engineers and Land Surveyors; and directing distribution.

SUBJECT: Permanent rules of the State Board of Licensure for Professional Engineers and Land Surveyors

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, any rule which establishes or increases fees or any rule by an agency, board, or commission created by or that receives its authority from Title 59 of the Oklahoma Statutes shall require approval by the Legislature by joint resolution. If the Legislature fails to approve the rule on or before the last day of the legislative session, the rule shall be deemed disapproved; and

WHEREAS, the permanent rules adopted by the State Board of Licensure for Professional Engineers and Land Surveyors on March 29, 2013, reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:


